Speaking on

**“The civil justice reforms and whether insolvency proceedings
should be exempt”**

The speaker will be introduced by John Powell QC of 4New Square.

Lord Justice Jackson was educated at Christ's Hospital and Jesus College, Cambridge, of which he is an Honorary Fellow. As an undergraduate, he served as President of the Cambridge Union. He was called to the Bar in 1972 (Middle Temple) and made a Bencher in 1995. He became a Queen's Counsel in 1987. Lord Jackson was a Recorder from 1990 until 1998, and was appointed a Deputy High Court Judge in 1993. In 1999, he was appointed a Judge of the High Court of Justice and assigned to the Queen's Bench Division and was knighted the same year. He later served as the judge in charge of the Technology and Construction Court from 2004 to 2007. On 2 October 2008, Jackson was appointed a Lord Justice of Appeal, and he received the customary appointment to the Privy Council the same year. In January 2009 he was asked by the Master of the Rolls to undertake a comprehensive review of civil litigation costs. He produced a Preliminary Report in May 2009. The Final Report was published in January 2010. Most of the recommendations were implemented in 2013.
